### **PERSONAL DATA PROCESSED**

The personal data hold by BTicino S.p.A. (controller for processing the data) are:

- Name, surname, e-mail, phone, company, VAT registration number (“**common**” data);

### **PURPOSES OF THE DATA PROCESSING – LEGAL BASIS - DATA RETENTION PERIOD**

The personal data are processed within of normal Biticino S.p.A.’s activities and according the below purposes:

1. Carry out the application request as a new supplier of the Company  
**Legal base of processing data:** need to carry out an interested party's request or to fulfil to pre-contractual misures of which interested party is part;  
**Data retention period:** the data will preserve for two years since of the fulfillment's date of application request.

Over pass the retention's deadlines above mentioned, the personal data will be destroyed, cancelled or became anonymous, compatibly with cancellation and backup's techniques procedures.

### **NATURE OF THE CONFERMENT**

The data's conferment to purposes above mentioned is obligatory to fulfillment the application's request.

### **AUTHORIZED SUBJECTS AND RECIPIENTS OF THE DATA**

The data may be processed by employees of business functions responsible for the pursuit of the aforementioned purposes, who have been expressly authorized for processing and who have received appropriate operative instructions from the Data Controller.

The data can be processed, on behalf of the company, by subjects designed as responsible to which are imparted adequate operative instructions (such as, as an example, companies that perform the management and/or maintenance service of the company's web site).

### **RIGHTS OF THE INTERESTED PARTY, REFERRED TO IN ARTICLE 7 OF D.LGS. N. 196/2003**

In relation to the processing of your personal data, you can ask the Data Controller:

- access to data concerning you (Article 15 of the GDPR);
- their integration adjustment (Article 16 of the GDPR);
- data deletion (Article 17 of the GDPR);
- the limitation of processing (Article 17 GDPR);
- oppose the use in cases of legitimate interest of the data controller (art. 21 GDPR);
- the receipt of data in a structured format, in common use and machine readable from an automatic data-processing machine, and, if technically feasible, to transmit them to another controller without impediments ("right to data portability", Article 20 of the GDPR);
- revoke the consent given at any time. (Article 7 of the GDPR).

We also remind you of the right to lodge a complaint with the competent Supervisory Authority (Article 13 of the GDPR).
